In fact, not much of everything bothers you. Not the pain of your recurring ear infections. Not jumping birthday parties and travel to the park because they are not accessible. Not eating brocolis for dinner. This is partly because she is easy by nature. But it is also in part because an exclusion in your genetic code makes it unable to understand much of what happens in the world around her. My daughter does not know that when you use the word r you are saying that she is stupid. She does not know that you are saying that you do not think that is as worthy as a child born without deficiencies. But although she does not know that, I do it. I know you're judging her and hurting her. You are perpetuating the idea that individuals with deficiencies do not deserve to be complete members of society. You are reinforcing the idea that they do not deserve the same respect and rights granted to others. This makes everything very easy to turn the contrary, when children with intellectual deficiencies are intimidated in school, to cut very necessary funds for doctors for individuals with disabilities, reduce budget For special education programs. It also makes my daughter invisible, not a person to be considered. After all, she is not the sweet girl who has a smile for everyone, who radiates pride when her body No cooperative allows her to take a few steps not attended, and that is delighted to examine the pages of any book she can find. When you use the word R, it is not a playful girl, a person to be loved. She is just just Á ě á § "Retard. á ě → For these reasons and many others the word R bothers me enough for both us, I know many of you are rolling your eyes, thinking that this is a common expression and that I should enlighten me. I'm sure it's what the mother who said she was "retarded by getting lost" on the way to a party in a room full of four-year-old children, this last weekend thinks. It is also what my friend who told me that they asked him "questions" in a presentation last week. This thought that allows the continuation of the marginalization of individuals with deficiencies. This thought leads to playgrounds and schools being built that are not accessible to everyone. Which leads to the additional marginalization of children as my daughter. Even if we change this thought, and our language, many will continue to think of individuals with deficiencies, not as people who are valuable members of society, but as something less. Something Á á ě ‡ á "retarded á ě œE that can be easily pushed aside and mistreated. This is not something that I can take from a lightweight. It is not something that any of us must accept. If you value in a diverse and inclusive society, where all are valued, please think before you speak - and always speak that you hear the word R. We are all better for this.
